The company, which has been on the market since 1991, supplies farmers with first-rate John Deere and JCB tractors and agricultural machinery, ÖVERUM ploughs from Sweden, HORSCH LEEB and HARDI sprayers, HORSCH tillage machines, as well as products from KRAMPE, BRIRI, TEBBE, HAUER, BOGBALLE, not to mention GRAMMER seats, TRIMBLE precision farming GPS navigation and many other brands.



Municipal equipment worth mentioning includes ANTONIO CARRARO mini tractors and municipal carriers, BERTI mulchers, JBM wood chippers, GRILLO lawnmowers, BOSCHUNG municipal carriers, WIEDENMANN snow ploughs and winter maintenance brushes, and more.

Road equipment includes MULAG ditch cleaners, ATC asphalt thermal containers, and WESTA snow blowers.


In March 2014 PEKASS a.s. became the official direct representative of JCB in the Czech Republic for farming machinery (tractors, handlers and loaders).






PEKASS a.s. total turnover in 2004–2022

PEKASS was established in 1991 with the idea of creating a sales network covering the Czech Republic. It celebrated its 30th anniversary in 2021.

The company now operates out of ten branches: From Prague 10 - Uhřetěves, where the head office is located, from Milovice, Nýřany, Příbram, Rakovník, Roudnice nad Labem, Rychnov nad Kněžnou and Vlašim.

The first quarter of 2014 saw the completion of the new modern branch near Roudnice nad Labem (by exit 29 off the D8 motorway); in early 2015 the Rychnov branch moved to larger premises (Pohoří u Dobrušky), and there has been a branch in Jindřichův Hradec since September 2015. The latest (tenth) branch has been open near Strakonice and Vodňany since 2021, and another is in the pipeline.



In 1998 PEKASS expanded to include municipal equipment and since then, besides sales, has also been importing and servicing special machinery for the maintenance of grassland, cleaning public areas and roads, winter maintenance, etc. Customers' growing interest in these machines led the company to branch out in a third direction in 2003 – road equipment.

A significant milestone for the company came in August 2005, when PEKASS was transformed into a joint-stock company.

PEKASS currently has over 140 employees and, for example, in 2008 it achieved a turnover of over CZK 750 million. The following years were marked by a slump in all areas of our economy. Since 2010, the company's sales have been rising again, and as a result of our increased efforts, the growth effect was also significantly reflected in sales of spare parts and in the amount of service work carried out in sales and service centres in the Czech Republic. Turnovers since 2012 have already exceeded CZK 750 million (between 2013 and 2019, for example, they regularly surpassed CZK 800 million).

At the end of 2021, the company reached its dream turnover target, one billion CZK.

Financing

An important means of supporting sales is corporate financing in the form of a loan or leasing. This service, called PEKASS FINANCE, is offered under the slogan "Custom Leasing". An individual approach to each case of financing is implemented directly at each customer's site, to suit their specific conditions. This saves the customer both time and further costs.




Assistance services

Our PEKASS ASSISTANCE is an unrivalled service. It is a comprehensive product arranged on top of the normal or extended warranty. It gives machine owners the certainty that, when they are using the technology, no unforeseen costs will arise that will significantly affect the economy of the machine's operation.







Service



As our sales increase, the standard of the service work we offer is also gradually increasing – PEKASS SERVICE. For repair work, the centres have very well-equipped workshops covering a total area of over 6,000 m² and more than 40 service vehicles. Warranty service within 24 hours is not just an advertising slogan, but a real bonus that is certainly far from standard in other fields. Imported assortments are distributed in areas outside the Central Bohemian region through contractual partners all over the Czech Republic. We make sure that not only our sales managers are well trained, but above all our service technicians. This is the only way to guarantee that the equipment we sell is given the best possible care.

Spare parts

Besides sales and servicing of machinery, sales of spare parts have been one of the cornerstones of PEKASS's business for 30 years now. The link between these three sectors is very important for customers who, when buying a machine, expect not only that it will work flawlessly but also that they have access to a smooth supply of spare parts and professional service. Proof that our customers appreciate this approach can be seen in the company's constantly rising revenues.

In addition to our company providing spare parts for direct sales to customers and its service activities, the spare parts department also provides wholesale sales to customers in the Czech Republic and abroad. A central spare parts warehouse for customers – our Distribution and Logistics Centre - also operates out of the PEKASS branch in Milovice.



After-sales care

Modern-day machines are highly complex, and so an after-sales care department has been set up for customers – PEKASS AFTERSALE. It is there to provide customers with technical support, approve machines for operation, and handle complaints, all in one place. The staff have an overview of up-to-date manuals for the machines and pass on service information to customers and service technicians, and also enable them to constantly build on their expertise in the form of training, either in this country or with our equipment suppliers abroad.



Machine hire centre

The last and also the most recent service is the PEKASS HIRE CENTRE. This was established by PEKASS in early 2017 and enables customers to hire seasonal machinery or cover the absence of their own machine in the event of a breakdown.







Original wholesale PPP

PEKASS PREMIUM PARTS (PPP) – these are products that can be characterised as the best on the market in terms of quality and utility value. No compromise on quality, no aftermarket. PPP products can also be considered original in terms of belonging to a certain brand of technology, but are at the same time purchased from a distribution chain that has no redundant links. JCB

JCB has strong farming roots that date back to 1945, when Joseph Cyril Bamford built his first agricultural trailer. All these years of experience mean that today JCB has a perfect understanding of agriculture and realizes that when it comes to agricultural machinery, the highest possible performance and productivity are required.

This is also the reason why this British company constantly invests in the development of specialised agricultural machinery that meets the ever-changing needs of farmers. Their machines include, for example, the telescopic handlers introduced in 1977, agricultural wheeled loaders from 1983, and the world's most productive tractor, the Fastrac from 1991. This is still the world's only full-suspension high-traction tractor capable of reaching speeds of up to 70 km/h.



JCB believes in the need to use innovation and technology to make their equipment as efficient as possible. In 2006, they introduced the TorqueLock system to reduce fuel consumption and increase top speed. In 2010, they patented an adaptive load management system that increases the safety and stability of telescopic machines. In 2012, they presented the JCB EcoMAX, a revolutionary and award-winning engine used in many JCB machines, including AGRI telescopic handlers.

In recent years, they have introduced several innovative features that help take productivity and efficiency to an even higher level. These include the state-of-the-art LiveLink telematics system, the JCB DualTech Variable Transmission, the Smart Hydraulics system, the Auto Smooth Ride system, Activ Traction technology and hydrostatic dual steering.

At the end of 2021, JCB announced that it would be investing 100 million pounds in a project for the manufacture of super-efficient hydrogen engines.

JCB's hydrogen technology will further be showcased in the "Green Zone" at COP26 in Glasgow, where world leaders will debate measures aimed at drastically reducing greenhouse gas emissions. JCB's emergence as a leader in zero-emission hydrogen technology comes as governments around the world unveil strategies to develop the infrastructure needed to support the use of hydrogen to reduce CO₂ emissions.

Since 1957, HARDI has been committed to meeting the ever-increasing demand for efficient and precise plant protection.







The company's greatest potential lies in people


